01.10 Apologies for Absence

Councillors considered the financial update and bank reconciliation.

Resolved: the financial update be received and accepted and signed by the Chairman.

Councillors Almond and Forrest left the meeting.

Councillors considered a grant request from Croston Community Centre towards the cost of refurbishment of the kitchen area. It was mentioned that a grant of £500 had been awarded, in October 2009, towards the refurbishment of the toilets. Councillors felt that, as the building is used by a number of local community groups, further assistance should be provided.

Resolved: a grant of £1000 be awarded.

Councillors Almond and Forrest rejoined the meeting.

A request for a contribution towards the costs of installation of a security gate for the passageway between no's 38 - 40 Westhead Road was considered. Councillors expressed concerns regarding the obstruction of a right of way for the adjoining properties and using public funds for, what was considered to be, a private issue. The was no proposer for the application.

07.10 2010 - 2011 Precept

Prior to the setting of the Precept the existing subscriptions to the Lancashire Association of Local Councils, Ormskirk, Preston and Southport Travellers Association and the Campaign for the protection of Rural England and entries to Lancashire Best Kept Village and North West in Bloom competitions were reviewed.

Resolved: the existing subscriptions and competition entries be continued.

08.10 Streetscene Delegated Services Protocol

A consultation document whereby the Parish Council may bid to provide services which are currently the responsibility of Lancashire County Council was considered. The Parish Council is expected to identify the services and develop a business case which would require the obtaining of quotations or tenders, completion of risk assessments and identification of Health and Safety procedures and the cost of the service to Lancashire County Council. It was felt that, as information regarding costings and procedures is already available to the County Council, the procedure should be amended whereby the Parish Council is provided with this information upon completion of an expression of interest.

09.10 Joint Lancashire Mineral and Waste Development Framework

Councillors considered a consultation document regarding possible minerals and waste site allocations and development management policies. Nothing was found in the document directly affecting the village and the details of the document were noted.
