### 11.18 Apologies for Absence

Apologies were received from Councillors M Cowley and K Ward.

### 12.18 Disclosure of Personal/Prejudicial Interests

Cllr Fenemore, as a Member of Croston Sports Club, declared a non-pecuniary interest in agenda item 6(ii) (Financial Matters).

### 13.18 Minutes of the Meeting held on the 10 January 2018

### 14.18 Public Participation

A representative of Croston Sports Club provided background information and answered questions from Councillors in relation to the grant application.

A resident reported grit from resurfacing on the pavement on Moor Road, towards The Mill.

Potholes were reported on the mini roundabout by Station Bridge.

Residents queried the current position regarding the consultation on the possible closure of Town Bridge. Councillors advised Lancashire County Council is collating the responses at present.

A resident offered congratulations to all involved in the village reaching the semi-finals of the Channel 4 Village of the Year.
